

## 2017-2018 Fruitland School District Registration

It is hard to believe we are already gearing up for our next school year!! Fruitland School District will be using online registration again and we would like to encourage all families that will be **returning** to the district to go online and register now so that part of the process will be completed. We are opening the portal for registration on May 5, 2017 and, if you have access to the internet, you may register any time after that. If you **do not** have access to the internet, you will be able to register your student(s) on August 3rd & 4th. At that time, the computer labs in all the schools will be available to register your students online.

**Please note:** *You will register all your students at once, you will not need to fill out the online registration for each individual student. To make the online process easier, please make sure you have all pertinent information handy when you begin.*

**If you have a parent portal account, please log into Parent Portal and click on the Online Registration tab.** If you cannot remember your credentials or password to the portal, please email [parentportal@fruitlandschools.org](mailto:parentportal@fruitlandschools.org) and your credentials will be sent to the email address in our student information system.

**After the online portion is complete, you may still need to attend the August 3rd and 4th registration events. Below are the requirements for each school.**

### **FRUITLAND MIDDLE SCHOOL:**

**All students must show proof of residency (utility bill, rental/mortgage agreement)**

Current immunization records (New students & returning 7th grade)

Updated Medical Form all students

All student athletes that have not played a school sanctioned sport are required to have a sports physical prior to the 1st practice. Medical Consent forms must be filled out for every athlete each new school year prior to the 1st practice.

Fees may be paid in the office beginning Aug. 3rd

**FRUITLAND HIGH SCHOOL:**

Proof of residency if address has changed

Schedules will be available on Parent Portal beginning August 3rd

Schedule changes and Fee Payments can be made at the high school on August 3rd & 4th

All other paperwork will be completed the first week of school
