Bayley reported the Elementary & Middle School students and staff has been wearing masks and has had no cases. But in the High School more cases have been reported.</p>

Bayley reported a survey was done among the staff in favor of students wearing a mask:

- Elementary: 81%
- Middle School: 100%
- High School: 100%

Bayley recommend approving Policy 3255C “Student Dress During Health Emergency”, which covers wearing masks or appropriate face coverings.

Masks and Personal Protective Equipment

The District requires each student to wear a mask or other appropriate face covering that shields the mouth and nose to protect themselves, their peers, and District staff while present in any school building. The District shall provide face coverings to students and expects that the face coverings be washed on a regular basis to ensure maximum protection. The Board’s decision to require and provide face coverings is based on a review of the circumstances in the community and consultation with local health officials on issues including, but not limited to, the possibility of exposure and availability of suitable face coverings.

A motion was made by Frye and seconded by Hurrell to approve the school closure for Fruitland High School due to the health and safety of students, staff and community members, as presented. The motion was unanimously approved.

.2 Policy 3255C – Student Dress During Health Emergency

A motion was made by Howell and seconded by Frye to adopt Policy 3255C, “Student Dress During Health Emergency” which will require face coverings of staff and students while we are in session during the pandemic as presented. The motion was unanimously approved.
